This study provides a general comparative reference of adhesive testing standards between ASTM International standards and related ISO (International Standards Organization) standards. This study is focused on ICS field 83 (Rubber and Plastics), Section 83.180 (Adhesives) within the overall ISO structure.

ASC commissioned Chemsultants International Inc. to develop this guide which identifies key similarities and differences between the comparable adhesive testing methods of the two international standards bodies. It is limited to an overall focus specific to general adhesive testing methods and does not purport to address adhesive testing methodologies that may be inherent in the overall standards of/for specific industries or applications such as Building Materials, Furniture, Footwear, or others.
